WHAT IS THIS PRODUCT?

Type:	UCITS
Term:	This product is not subject to any fixed term.
Objectives:	To provide long term growth through diversification across major asset classes.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
