Objectives and Investment Policy

Investment Objective:

The investment objective of the Fund is to generate income by predominantly taking positions in a variety of CIS.

Investment Policy:

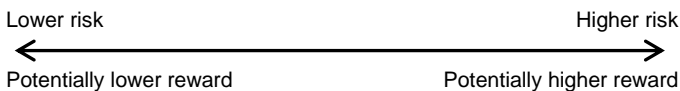
The Fund will invest in a diversified portfolio of authorised open-ended UCITS and/or Exchange Traded Funds and alternative investment funds (together "CIS"). The Fund may invest more than 20% in emerging markets. The CIS that the Fund may invest in will be authorised as UCITS or alternative investment funds, consist of regulated collective investment schemes which may be domiciled in a member state of the EEA, the U.S., Jersey, Guernsey or the Isle of Man. The CIS will invest in principally fixed income securities on a global basis. The Fund may also invest in a CIS with exposure to other asset classes: money market instruments, property, private equity, absolute return funds, managed futures and hedge funds. The asset allocation strategy may be altered by the Investment Manager on a monthly basis or more frequently to take into account changes in the expected risk and correlations of the underlying asset classes. The Fund may also invest directly in assets for short term liquidity, pending investments or defensive purposes i.e. direct cash, deposits, money market instruments.

Other Information:

- The Fund may use FDIs for efficient portfolio management and currency hedging purposes. Such techniques and instruments include options and forwards.
- You can buy, exchange and sell shares in the Fund on a weekly basis in Dublin.
- This class does not intend to pay a dividend. Any income generated by the Fund is reinvested to grow the value of your investment.
- The Fund may not be appropriate for investors who plan to withdraw their money in 2-3 years.

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

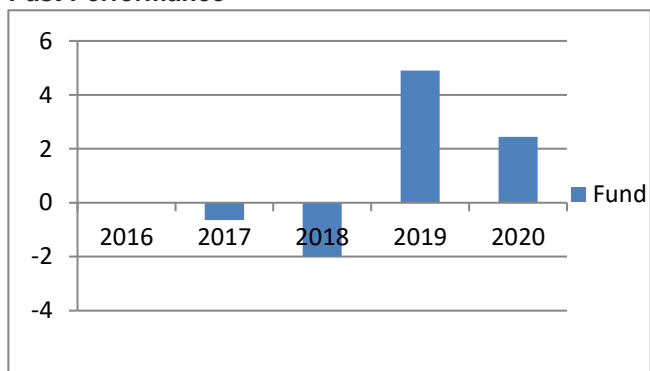
