## **Objectives and Investment Policy**

#### **Investment Objective:**

To seek total returns with an emphasis on long term growth but with the potential for some degree of income generation.

#### **Investment Policy:**

The Fund will invest in a diversified portfolio of authorised open-ended UCITS and alternative investment funds ("CIS"). The CIS that the Fund may invest in will be authorised as UCITS or alternative investment funds, consist of regulated collective investment schemes which may be domiciled in a member state of the EEA, the US, Jersey, Guernsey or the Isle of Man. The underlying collective investment schemes will invest in principally equity securities and fixed income on a global basis. The asset allocation strategy may be altered by the Investment Manager on a monthly basis or more frequently to take into account changes in the expected risk and correlations of the underlying asset classes.


