### Objectives and Investment Policy

#### Investment Objective:

The investment objective of the Fund is to achieve long term capital growth by predominantly taking positions in variety of Collective Investment Schemes.

#### Investment Policy:

The Fund will invest in a diversified portfolio of authorised open-ended UCITS and/or Exchange Traded Funds and alternative investment funds (together "CIS"). The CIS that the Fund may invest in will be authorised as UCITS or alternative investment funds, consist of regulated collective investment schemes which may be domiciled in a member state of the EEA, the U.S., Jersey, Guernsey or the Isle of Man. It is intended that the Fund will be managed to operate in normal circumstances on a long only basis. The CIS will invest principally in a diversified portfolio of equity securities on a global basis. The Fund may also invest in a CIS with exposure to other asset classes: money market instruments, property, private equity, absolute return funds, managed futures and hedge funds. The asset allocation strategy may be altered by the Investment Manager on a monthly basis or more frequently to take into account changes in the expected risk and correlations of the underlying asset classes. The Fund may also invest directly in assets for short term liquidity, pending investments or defensive purposes i.e. direct cash, deposits, money market instruments.

- The Fund may not be appropriate for investors who plan to withdraw their money in 2-3 years.

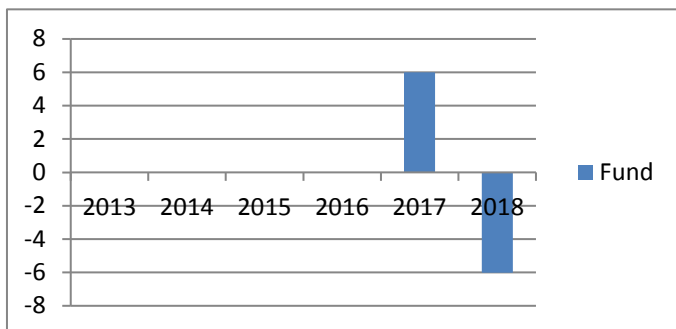
