Objectives and Investment Policy

Investment Objective:

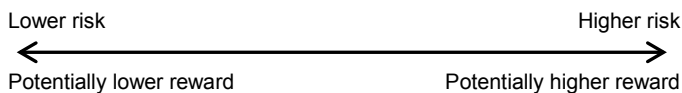
The investment objective of the Fund is to achieve a rate of return in excess of inflation while seeking to minimise volatility of returns by investing in a diversified portfolio of predominantly

defensive assets.

Investment Policy:

The Fund will invest in a diversified portfolio of authorised open-ended UCITS and alternative investment fund ("CIS"). The CIS that the Fund may invest in will be authorised as UCITS or alternative investment fund CIS, consist of regulated collective investment schemes which may be domiciled in a member state of the EEA, the U.S., Jersey, Guernsey or the Isle of Man. The underlying investment schemes will invest in principally equity securities and fixed income on a global basis. The asset allocation strategy may be altered by the Investment Manager on a monthly basis or more frequently to take into account changes in the expected risk and correlations of the underlying asset classes.

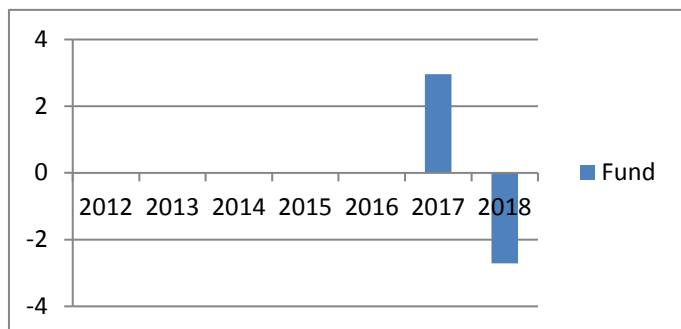
