### Objectives and Investment Policy

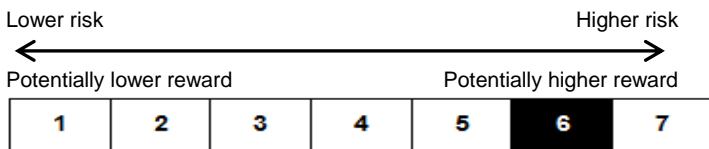
#### Investment Objective:

To provide long term capital growth spreading the risk through geographical and sector diversification whilst predominantly taking long only investment positions in mostly UK, European and US equity markets with some exposure to Japan, the Far East and emerging markets

#### Investment Policy:

The Fund will seek to achieve its investment objective by investing primarily in equity securities and in Exchange-Traded Funds ("ETFs"). The Fund may also, to a lesser extent invest in Collective Investment Schemes ("CIS"). The securities invested in will provide exposure predominantly to UK, European and US equity markets with some exposure to Japan, the Far East and emerging markets. The CIS that the Fund may invest in will be authorised as UCITS or alternative investment fund, consist of regulated collective investment schemes which may be domiciled in a member state of the EEA, the U.S., Jersey, Guernsey or the Isle of Man.

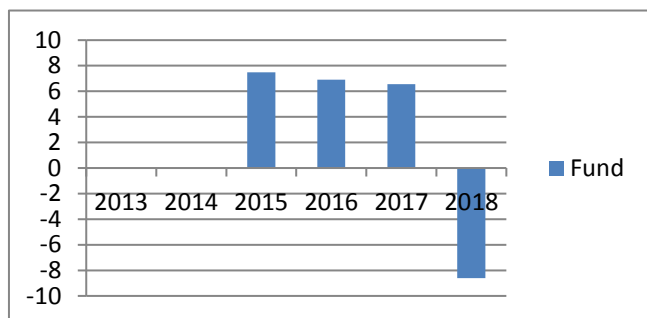
