## Objectives and Investment Policy

### Investment Objective:

The investment objective of the Fund is to seek to provide steady capital appreciation by investing in a diversified portfolio of both UK and overseas investments.

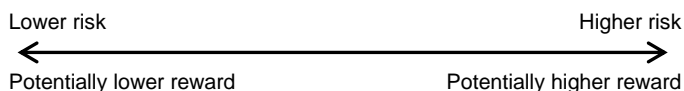
### Investment Policy:

The Fund will invest in a diversified portfolio of authorised open-ended UCITS and alternative investment funds ("CIS"). The CIS that the Fund may invest in will be authorised as UCITS or alternative investment funds, consist of regulated collective investment schemes which may be domiciled in a member state of the EEA, the U.S., Jersey, Guernsey or the Isle of Man. The CIS will typically be domiciled in Ireland, the United Kingdom and Luxembourg. The CIS will invest in principally equity securities and fixed income securities to provide exposure to European and North American equity markets with some exposure to Japan, the Far East and emerging markets.

The Fund may also invest in CIS with exposure to: money market instruments, property, private equity, cash, commodities, managed futures or may pursue an absolute return fund strategy and hedge fund strategy (long/short fund and global macro funds).

The asset allocation to CIS may be altered by the Investment Manager on a monthly basis or more frequently to take into account changes in the expected risk and correlations of the underlying asset classes.

### Other Information:

- The Fund may use FDIs for efficient portfolio management and currency hedging purposes. Such techniques and instruments include options and forwards.
- You can buy, exchange and sell shares in the Fund on a daily basis on any business day in Dublin.
- Subject to net income being available for distribution, the Directors intend to declare dividends on the distribution date, which shall usually be 31 March and 30 September in each year (the "Distribution Date"), and such dividends will be paid on or before the 14th Business Day following the Distribution Date.
- The Fund may not be appropriate for investors who plan to withdraw their money in 2-3 years.

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

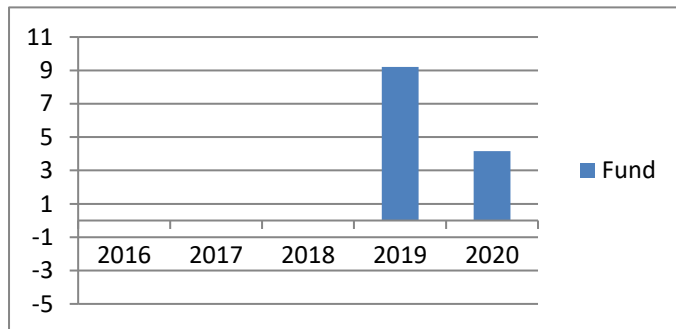
