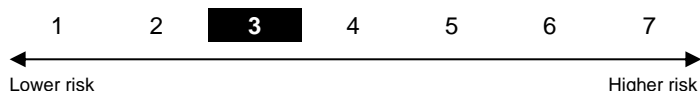
#### Objectives:

The investment objective of the Fund is to achieve long term capital growth by investing primarily in a portfolio of higher risk assets.

#### Intended Retail Investor:

Investors who have longer term investment objectives, and who are willing to accept a higher degree of volatility in pursuit of higher returns over this period.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



**The risk indicator assumes you keep the product for 9 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.**

#### Risk indicator

**We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.**

### Costs over Time
