The Fund is managed by IQ EQ Fund Management (Ireland) Limited (the Manager").

Objectives and Investment Policy

Investment Objective:

The investment objective of the Fund is to achieve moderate capital growth by investing in a balanced portfolio of domestic and international equities, fixed interest securities and alternative investments.

Investment Policy:

The Fund will invest in a diversified portfolio of authorised openended UCITS and alternative investment funds ("CIS"). The CIS that the Fund may invest in will be authorised as UCITS or alternative investment funds, consist of regulated collective investment schemes which may be domiciled in a member state of the EEA, the U.S., Jersey, Guernsey or the Isle of Man. The underlying investment schemes will invest in principally equity securities and fixed income on a global basis. The asset allocation strategy may be altered by the Investment Manager on a monthly basis or more frequently to take into account changes in the expected risk and correlations of the underlying asset classes.


