

WHAT IS THIS PRODUCT?

TYPE:	This Product is an Alternative Investment Fund
OBJECTIVES:	The investment objective of the Irish Residential Private Rented Sector Fund is to achieve long term income and capital appreciation by investing in existing properties and newly developed private rented residential property and property related assets located in Ireland. Investors should be aware that their capital is at risk and that there is no guarantee that the investment objective will be achieved over any time period.
INTENDED RETAIL INVESTOR:	The Irish Residential Private Rented Sector Fund 2 is targeted at Professional Clients and Retails Clients. The investor's objective for this investment should be aligned with that of the Product as outlined above.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

COSTS OVER TIME
