Objectives and Investment Policy

Investment Objective:

To seek returns with a balance between capital growth and income generation with lower volatility than a typical long term growth strategy.

Investment Policy:

The Fund will invest in a diversified portfolio of authorised open-ended UCITS and non-UCITS collective investment schemes ("CIS"). The CIS that the Fund may invest in will be authorised as UCITS or non-UCITS CIS, consist of regulated collective investment schemes which may be domiciled in a member state of the EEA, the U.S., Jersey, Guernsey or the Isle of Man. The underlying investment schemes will invest in principally equity securities and fixed income on a global basis. The asset allocation strategy may be altered by the Investment Manager on a monthly basis or more frequently to take into account changes in the expected risk and correlations of the underlying asset classes.

Other Information:

- ▶ The Fund may use FDIs for efficient portfolio management and currency hedging purposes. Such techniques and instruments include options and forwards.
- ▶ You can buy, exchange and sell shares in the Fund on a daily basis on any business day in Dublin.
- ▶ This class does not intend to pay a dividend. Any income generated by the Fund is reinvested to grow the value of your investment.
- ▶ The Fund may not be appropriate for investors who plan to withdraw their money in 2-3 years.

Charges
