### Objectives and Investment Policy

#### Investment Objective:

To provide long term growth through diversification across major asset classes.

#### Investment Policy:

The Fund will invest in a diversified portfolio of collective investment schemes with exposure predominantly to UK, European and US equity markets with some exposure to Japan, the Far East and emerging markets. The underlying collective investment schemes will invest in principally equity securities and fixed income on a global basis. The asset allocation strategy may be altered by the Investment Manager on a monthly basis or more frequently to take into account changes in the expected risk and correlations of the underlying asset classes.

#### Other Information:

- ▶ The Fund may use FDIs for efficient portfolio management and currency hedging purposes. Such techniques and instruments include options and forwards.
- ▶ You can buy, exchange and sell shares in the Fund on a daily basis on any business day in Dublin.
- ▶ Subject to net income being available for distribution, the Directors intend to declare dividends on the distribution date, which shall usually be 30th June and 31st December in each year (the "Distribution Date"), and such dividends will be paid on or before the 14th Business Day following the Distribution Date.
- ▶ The Fund may not be appropriate for investors who plan to withdraw their money in 2-3 years.

## Charges
