### Summary of Objective<sup>1</sup>

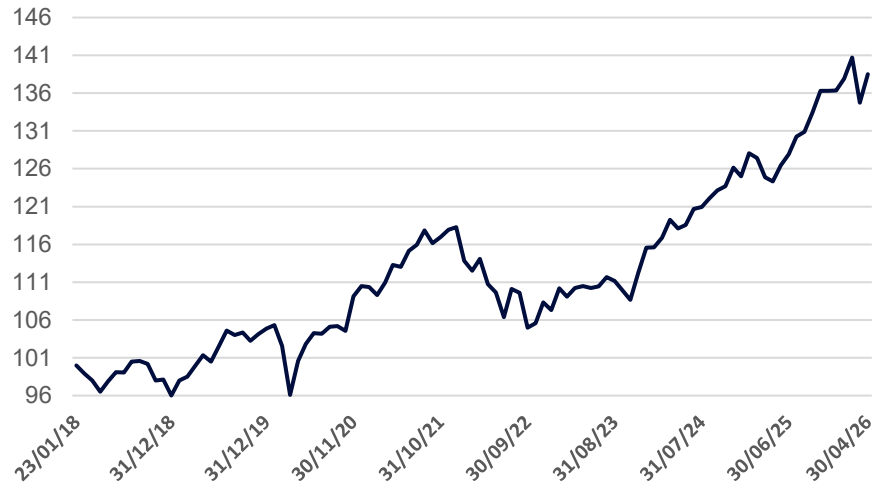
The objective of the Fund is to achieve steady capital appreciation by investing in a diversified portfolio of both UK and overseas investments.

Figure 2: Asset Allocation

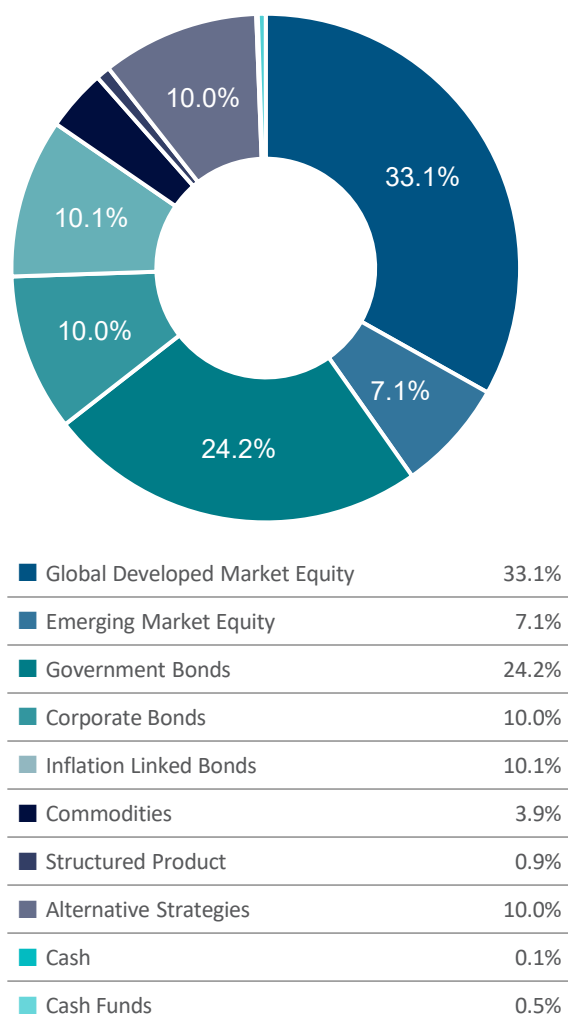
