### Summary of Objective<sup>1</sup>

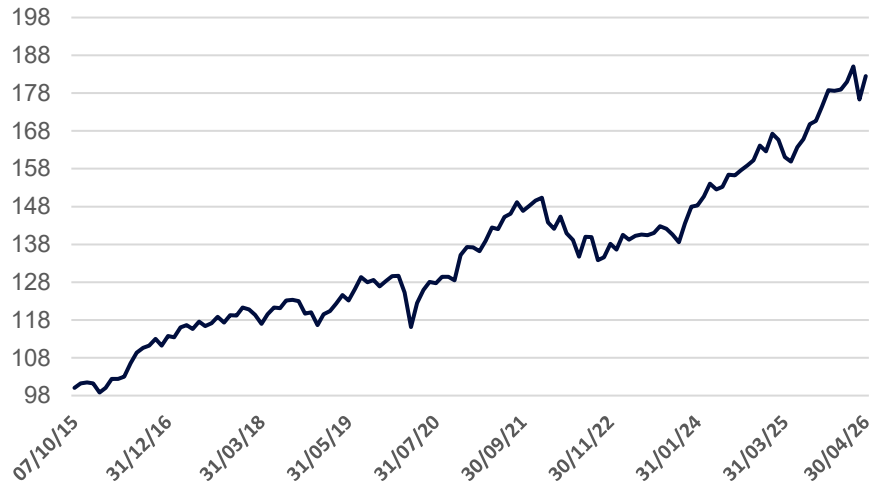
The objective of the Fund is to achieve moderate capital growth by investing in a Moderate portfolio of domestic and international equities, fixed interest securities and alternative investments.

Figure 2: Asset Allocation

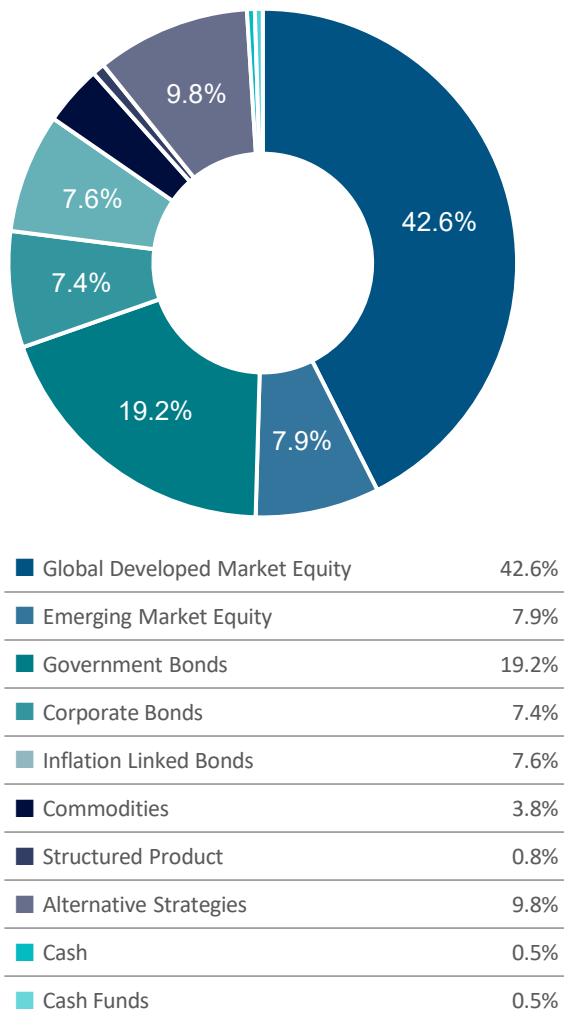
